- What criteria you need to meet
- How to make an application
- What documents you will need to apply
- What type of status you are eligible for
- Completing application forms

The service is available to people from the following groups:

Gypsy/traveller and Roma communities

Vulnerable individuals, including those who are:

- homeless
- elderly
- suffering with disabilities/serious health conditions
- victims of domestic abuse
- victims of modern slavery and human trafficking
- adults who have left care

- How to apply for and deal with complications in Welfare Benefits and advice

- How to report Hate Crime and Hate incidents experienced by yourself or someone else you know (anonymously if required).
